To Oregon Job's Daughters and Adults,

We are offering you the opportunity to sell ads for the 2008 Grand Session Yearbook to help with your Grand Session expenses. Seventy-five percent of the funds raised by ad sells will be used as credit for Bethel expenses for Grand Session registration or to defray cost of meals and housing at the Kaiser Renaissance Inn, formerly the Wittenberg Inn. Additional funds will be used toward the cost of the Session Yearbook and Grand Session expenses. For those ads that do not come directly from a Bethel, please be sure to indicate how you would like the 75% dispersed, i.e. toward expenses for an individual daughter, a Bethel, or to the general fund for Grand Session expenses.

The ads should be camera ready (preferred digital). The sizes are full page (8.5 x11") for \$100, half page (5 1/2 x 8) for \$60 quarter page for \$35 or business card for \$25. Credit information toward Grand Session will be sent out to participating Bethel by June 14th to assist Bethels in Session costs. This process will allow the credit for Grand Session expenses prior to Grand Session, rather than posting checks back to you afterwards. The GGC will write checks directly to the Wittenberg Inn for lodging costs defrayed by ads.

The accompanying forms should be used as a receipt for the advertiser and order form turned in with the ad. We hope your Bethel will take advantage of this opportunity to help defray the cost of Grand Session.
